WHAT YOU NEED TO KNOW ABOUT THE PROGRAM:

Applications are evaluated on a quarterly basis, the highest scoring applications of each quarter will be selected based on availability of funds. If your application is selected, you will receive a "Conditional Approval Letter", you will then have 90 days to turn in additional documentation detailed in the letter.

Once all documentation requested in the "Conditional Approval Letter" is received, UNPA will issue an "Approval Letter" that guarantees you will be provided the funds once the project is completed. You will have up to 6 months to complete the renovations.

Once the renovations are completed, mail invoices and after photos to UNPA. The after photos that show the improvements made are essential to the program. UNPA will then issue a "Ready to Schedule" letter to the Lawyer so that they contact you directly for the signature of the grant award and to hand you the check.

If you reside in the property for 10 years, the funds will be fully granted to you. Every year, you will respond to Verification of Occupancy letters to confirm that you are residing in the property. If you sell or rent the property before 10 years, you shall reimburse funds based on a sliding scale.

PLEASE SAVE ALL YOUR INVOICES IF YOU PROCEED WITH THE REPAIRS WHILE WAITING FOR APPROVAL OF YOUR APPLICATION.
